
Subsequent to it, in the No Objection Certificate issued on page 2, para-3, it is stated that, "As per provisions found in the affiliation Bye-Laws of CBSE the availability of the land qualifies the School for Secondary Level classes only". Whereas as per the Circular No.CBSE/Aif/Circular/2013/590527 dated 02.08.2013 with the availability of 80 cents of land (34,880 Sq feet) 3244 Sq mt in the school qualifies itself for Senior Secondary School as per extant orders.

Hence, necessary amendment to the order already issued as follows is made and the same may be read as "As per provisions found in the affiliation Bye-Laws of CBSE the availability of the land qualifies the School for Senior Secondary Classes.
